SETUP:

1. To charge your PS5® controllers firstly insert the supplied USB charging cable into the Charging Station and into an available USB port on the PS5® console
2. Insert the USB C Type adapter into your PS5® controllers C type socket located at the front of the controller; this adaptor allows the controller to dock with the charging ports on the Charging Station. x2 C Type adapters are supplied for 2 controllers.
3. Simply place the controller in the correct position on the Charging Station to commence charging.
4. Charging is indicated by an illuminated Red LED on the Charging Station.
5. When fully charged or when no controllers are being charged the Charging Station LED will be illuminated Green.
6. Two PS5® controllers can be charged simultaneously.

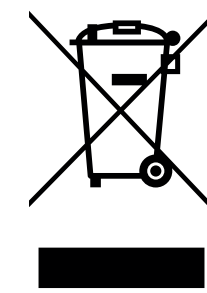
WARRANTY INFORMATION

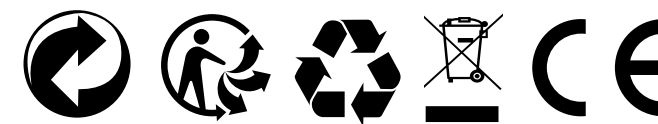
